Free legal help for low-income San Diego residents

If you are a low-income resident of San Diego County, you may be able to get free legal services. Call one of our offices to talk with an intake specialist. This person will ask you questions to see if you are eligible for free services. We use Federal Poverty Guidelines to determine if you can get free legal help. If you are eligible, you will talk with a legal worker. If we cannot help you, we will refer you to another agency.

We offer free legal services in these areas:

Immigration: Applications for Naturalization and Self-Petitions to Immigrate (for battered / abused spouses who need to immigrate without their spouse)

Estate Planning: Financial Powers of Attorney, Advance Healthcare Directives and Probate Conservatorships

Consumer Issues: Credit issues and small claims court advice

Mediation: Services to help families and youth resolve issues ranging from juvenile delinquency to school truancy. We also teach peer mediation techniques to elementary through high school students. Call (619) 471-2717 for information on mediation training.

Education and Advocacy

Representation at a School Expulsion Proceeding or help developing Individual Education Plans

Economic Impact Program for Non-profit Organizations

Our services for non-profit organizations include establishing 501(c)(3) status and providing tax advice regarding fundraising activities.
